



## **BROMLEY BASKETBALL CLUB – JUNIOR MEMBERSHIP TERMS AND CONDITIONS**

### **1. General**

The below terms and conditions relate to Bromley Basketball Club Junior membership and online registration.

Please read the Terms and Conditions carefully prior to using the online registration facility. Once payment has been taken this means that you have accepted the online registration terms.

Parents/ Carers must ensure and are responsible for giving the most up to date and accurate medical information about the child on the registration form.

Bromley Basketball Club cannot take responsibility in the event that inaccurate information is given in relation to a child's medical conditions.

### **2. Registration**

All available spots will be on a first-come first-serve basis via Bromley Basketball Club's website.

Once a parent/carer has registered their child via Bromley Basketball Club's membership registration form, an email confirming that Bromley Basketball Club has received your child's registration will be sent.

The membership will only come into effect once payment has been received. If payment is not made by the date stated on the confirmation email and/or online registration facility, the Club has the right to void the registration submitted and offer the membership spot to another parent/carer for their child.

Bromley Basketball Club is heavily reliant on such fees to operate, without these fees the Club would cease to exist. Membership fees must be maintained by all members to ensure playing eligibility. Bromley Basketball Club reserve the right to suspend membership if membership payments are not made.

You agree to Bromley Basketball Club sharing your contact details with other parties for administration and communication purposes. This may include, but is not limited to, the use of WhatsApp, Heja and group emails where your details may be visible to other parties through these communication tools.

### **3. Payment**

Bromley Basketball Club accepts payment by the following methods:

1. Bank Transfer – For membership fees in full only
2. Standing Order – For membership fees in instalments

Bromley Basketball Club does not accept cash or cheques.

Parents/carers are required to obtain a [Basketball England Membership Licence](#) before participating at the Club. This cost is in addition to Bromley Basketball Club membership fees.

#### **4. Refunds and Cancellations**

Once the season has commenced, Bromley Basketball Club will not issue refunds for general illness / injury or non-attendance. Membership fees is not based upon a fee per session; thus membership fees must be maintained, this is because the Club must commit in advance to expenses for the whole season.

In the event of a parent/carer making an overpayment, Bromley Basketball Club will offer a refund. Payments returned may be subject to bank charges, Bromley Basketball Club do not accept liability for bank charges.

If a cancellation prior to the start of the season is requested, Bromley Basketball Club will offer a refund. Payments returned may be subject to bank charges, Bromley Basketball Club do not accept liability for bank charges.

Bromley Basketball Club will not offer a refund if a cancellation is requested once the season has commenced.

If a cancellation occurs due to events beyond our control, Bromley Basketball Club will do its best to offer an alternative session, where possible. If this is not possible due to time constraints or court availability, the session will not be carried over to the following season.

Examples of which deemed beyond our control (but not limited to):

1. Unexpected school closure.
2. Road closures or traffic incidents.
3. Severe weather conditions
4. Unexpected last-minute cancellation of facility booking.
5. The start time of a basketball session/course is amended at the request of the facility.

#### **5. Arrival and Collection**

##### **Arrival**

Parents/Carers should ensure that their child arrives within 15 minutes of a session, so all sessions are able to start on time without interruption.

If child is late to a session, they must report directly to the coach so their attendance can be registered.

##### **Collection**

After the session, parents/carers must be available to collect their child at the advertised finish time of a session. In the event of late collections, Bromley Basketball Club reserve the right to charge an additional £5 per late collection.

Please note: All coaches have a variety of commitments and require to leave promptly. Bromley Basketball Club is not a registered childcare facility. The obligation and responsibility of collection by the advertised finish time is with the parent/carer.

If a child is travelling to/from a session individually, Bromley Basketball Club and its coaches must be informed of this either by parent/carer and/or child attending the session.

Once the child finishes/leaves a session, Bromley Basketball Club and its coaches' obligation and responsibility for the child will end at the finish time of the advertised sessions.

## **6. Behaviour**

Bromley Basketball Club and its coaches set the expectations of what behaviour is required from children at all times. Bromley Basketball Club and its coaches expect the child to enter the sessions with a positive, respectful and hard-working attitude.

Bromley Basketball Club coaches reserve the right to exclude a child from the session if it is deemed that the child's behaviour is disruptive causing an impact of other children's development.

A child shall not do anything in, on or about the premises that will cause damage to the facility. Should a child be found to have caused damaged, the parent/carer will be liable to cover the cost of damages. The child will be suspended from sessions and may have their membership removed in accordance to Bromley Basketball Club's disciplinary procedures.

In such circumstances, a refund will not be issued.

## **7. Medical Information**

Parents/ Carers must ensure and are responsible for giving the most up to date and accurate medical information about the child on the registration form, providing any updates to medical information to Bromley Basketball Club throughout the season.

Bromley Basketball Club do not take responsibility for the administration of medication during a session. Additional consent must be provided in writing. Bromley Basketball Club or its coaches accept no responsibility for injury caused by or during attendance on any activities organised by the Club except where the injury can be shown to result directly from negligence by the Club and its coaches.

By agreeing to these term and conditions, you allow Bromley Basketball Club and its coaches consent to respond in an appropriate manner in the event of an accident and injury.

In the event of an emergency, Bromley Basketball Club and coaches will seek the help of emergency services and contact the primary parent/carer at the earliest opportunity.

## **8. Lost Property**

Children should not bring valuable belongings to the sessions. Bromley Basketball Club or its coaches accept no responsibility for any loss or damage caused by or during attendance on any activities organised by the Club except where the loss or damage can be shown to result directly from negligence by the Club and its coaches.

Any lost property will be collected and stored with Bromley Basketball Club equipment. It is the responsibility of the parent/carer to contact Bromley Basketball Club to enquire about lost property. Should any items go unclaimed, items may be destroyed or donated to charity.

## **9. Photo, Video and Social Media**

You agree that Bromley Basketball Club may photograph or film your child's involvement in activities undertaken as part of the Club. These may be used to promote the Club's activities on our website or social media channels such as Facebook, Twitter and Instagram. Bromley Basketball Club will take all steps to ensure these images are used solely for the purposes they are intended. If you become aware that these images are being used inappropriately you should inform a member of staff immediately. Consent may only be withheld if there is a genuine safeguarding issue with respect to the junior member. (Please provide details via email).

If you do not wish for your child's involvement to be captured via photograph or film, please email the Club immediately after your registration form has been submitted.

## **10. Insurance**

Bromley Basketball Club Public Liability insurance covers our members for a full season of membership with the advertised start and finish date.
